This can include the past progressive (e.g. the Billy Goats Gruff <u>were eating</u>). Present perfect (e.g. What have you done?). Opportunities also exist for the use of the past perfect e.g. The children <u>had tried</u>...earlier in the day, the goblins <u>had hidden</u>... and Past perfect progressive forms e.g. the children <u>had been searching</u>... they <u>had been hoping</u> to find the treasure since they started on the quest ... Adverbials can be used e.g. therefore, however to create cohesion within and across paragraphs. These adverbials can take the form of time (later), place (nearby), and numbers (secondly). Modals can be used to suggest degrees of possibility, e.g. They <u>should</u> never have...If they were careful, the children <u>might</u> be able to... Adverbs of possibility can be used to suggest possibility, e.g. They were <u>probably</u> going to be stuck there all night..., they were <u>definitely</u> on the adventure of a lifetime... By writing for a specified audience and with a particular purpose in mind, the writer can choose between vocabulary typical of informal speech and that appropriate for formal speech e.g. the battalion traversed the mountain range; the soldiers walked over the mountains. 2. The passive voice can be used e.g. it was possible that..., the map was given to the children by..., more ingredients were added to the potion etc. 3. Writers may use conditional forms such as the subjunctive form to hypothesise, e.g. If the children were to get out of this situation..., if only there were a way to solve this problem..., I wished I were somewhere else... etc. 5. Past perfect progressive forms can be used to indicate specific points in time e.g. the children <u>had been searching</u>... I <u>had been dreaming</u> of riding a unicorn all my life... 6. Create cohesion across paragraphs using a wider range of cohesive devices such as organisational features, pronouns, nouns and adverbials. Or by choosing to use repetition or ellipses for effect. 7.
